FIRST: That the name of a said corporation shall be:

REMMANVILLE HOMEOWNERS ASSOCIATION, INC.

SECOND: That the purpose of said corporation are as follows;

- 1. To promote the best interest and well-being as well as safeguard the welfare of the residents and homeowners of REMMANVILLE, BETTER LIVING SUBDIVISION, Barangay Don Bosco, Municipality of Paranaque, Metro Manila;
- 2. To adopt such measures as may be necessary for the protection and safeguard of the interests of the members of the Association and their property consistent with law; and to provide for community police or security guards and fire prevention facilities within the REMMANVILLE, BETTER LIVING SUBDIVISION;
- 3. To make and adopt such rules and regulations concerning the use, enjoyment, occupancy and maintenance of all the property in the subdivision;
