**RHA1 VEHICLE STICKER RULES AND REGULATION**

- 1) RHA1-REV STICKERS IS NON-TRANSFERABLE AND SHALL REAMIN "PROPERTY" OF REMMANVILLE EXECUTIVE VILLAGE.
- 2) A NEWLY INSTALLED VALID VEHICLE STICKERS SHALL AND MUST BE RENEWED EVERY 15TH DAY OF JANUARY OF THE FOLLOWING YEAR.
- 3) THE/OR ALL EXPIRED VEHICLE STICKER MUST BE REMOVED OR WILL BE REMOVED BY RHA1 GUARDS ON THE EXPIRY DATE (every 15TH January).
- 4) RHA1 STICKER SHALL AND MUST NOT REMOVE OR MOVE TO ANOTHER VEHICLE WITHOUT THE PERMISSION OF RHA1.
- 5) RHA1 STICKER SHOULD AND MUST NOT BE BLOCKED BY OTHER STICKERS TO AVOID INCONVENIENCE BY RHA1 GUARD FOR VERIFICATION/INSPECTION..
- 6) RHA1 RESERVED THE RIGHT TO CONFISCATE/CANCEL ANY MISDISCLARED /MISUSED OR MISREPRESENTATION IN THE APPLICATION FORM.
- 7) COPY OF THE OFFICIAL RECEIPT PAYMENT OF VEHICLE STICKER MUST BE KEPT IN THE VEHICLE AT ALL TIMES.
- 8) ISSUED PASSING THRU STICKERS IS NOT ALLOWED TO GAIN ACCESS INSIDE RHA1 COMMUNITY. A CAR PASS SHOULD BE OBTAIN FROM THE GUARD.
- 9) ALL DRIVERS AND OWNERS OF PRIVATE OR COMMERCIAL VEHICLES SHALL AND MUST STRICTLY ABIDE WITH RHA1 TRAFFIC RULES AND REGULATION, ANY VIOLATION WILL RESULT TO CANCELLATION AND/OR CONFISCATION OF RHA1 ISSUED STICKER. THE SAID VEHICLE WILL NO LONGER BE ALLOWED TO ENTER THE COMMUNITY.
